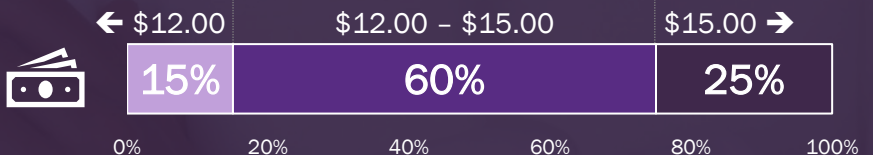


## DEMOGRAPHICS

July 2019 - June 2021



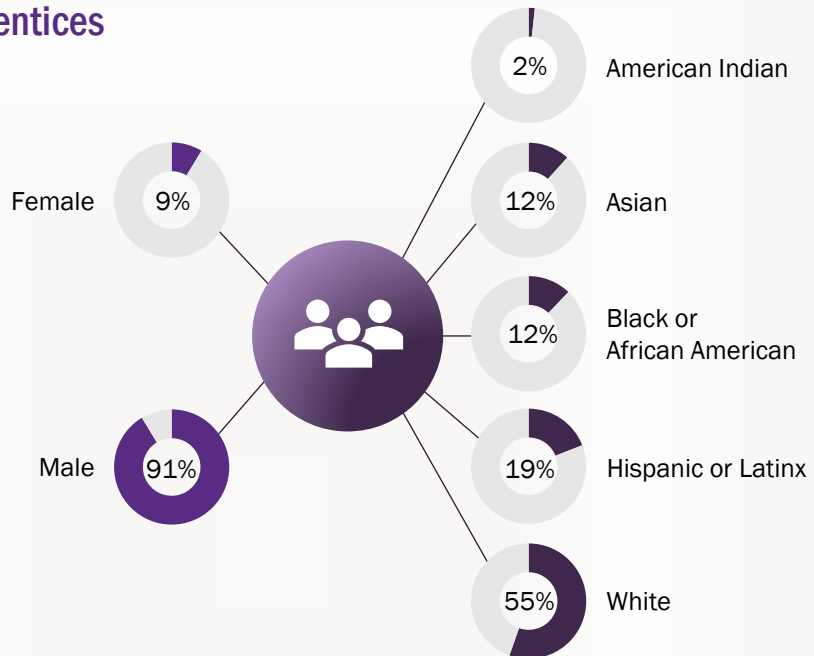
## HOURLY WAGES PAID TO CYAI APPRENTICES



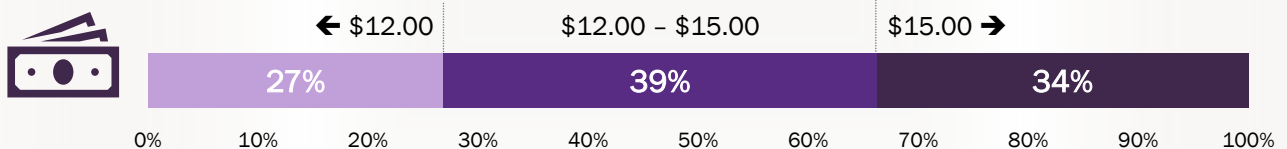
Cybersecurity Youth Apprenticeship Initiative (CYAI) is funded by the U.S. Department of Labor (DOL) Employment and Training Administration (ETA) Office of Apprenticeship (OA). CYAI promotes sustainable development of cybersecurity apprenticeship programs for youth aged 16–21. The goal of the initiative is to create at least 900 new cybersecurity apprentices for youth by 2024. CYAI is administered by ICF through a five-year contract and has served 448 youth participants since its inception in 2019. Year 2 ended on June 24, 2021.
